I feel a strong sense of duty to protect and serve our community in all aspects of life, including the rapidly evolving digital age where the internet and social media have become integral parts of our daily lives.

As these technological advancements enhance our lives, they bring certain risks.

I urge parents and guardians to engage in open conversations with their children about internet safety. Please educate children about the potential risks with sharing personal information online, engaging in phishing scams and interacting with strangers.

It's not just kids that are at risk. Adults in our community should remain vigilant to cyber threats. Please be cautious when sharing personal or financial information online. I advise you to regularly update passwords and ensure they are strong and unique.

A report published by the FBI reflected Americans lost \$10.3 billion in 2022 to a wide variety of internet scams.

The largest reported crimes were phishing expeditions. Phishing is defined as "the use of unsolicited email, text messages, and telephone calls purportedly from a legitimate company requestions personal, financial, and/or login credentials." The reason for such frequent success is because phishing emails will often resemble those from people victims know personally, prompting them to click on unsecured links. You may also receive an unexpected email or text message that looks like it is from a company you know and trust, like a bank, credit card or utility company. These messages may claim there's a problem with your account or your payment information, claim they need to confirm some personal or financial information, include an invoice you do not realize, want you to click on a link to make a payment, say your eligible to register for a government refund, or offer a coupon for free stuff.

I encourage you to help our office promote a safe and secure digital environment for everyone. By staying informed and vigilant, and by implementing responsible internet and social media practices, we can mitigate risks and protect ourselves and our loved ones from potential harm.

I would also like to thank you for your continued support in our mission to uphold safety and security in every aspect of our community's lives.

#### **DETENTION OFFICER ARRESTED**

On August 7th, 2023, Towns County Sheriff's Office Investigators Lt. Ryan Forsyth and Sgt. Mike Franklin received a tip that a cell phone had been smuggled into the Towns County Detention Center. The Towns County Detention Center Major James Baldwin ordered an immediate lockdown of the inmates, and a search was conducted, and a cell phone was located.

Investigators revealed that a Towns County Detention Center employee had smuggled the cell phone into the Detention Center and was given to a specific inmate.

The following person(s) was formally charged with the following:

Erin Ashley Brown, 36 of Young Harris, GA

- Violation of oath by public officer
- Obtain, procure, or give inmate prohibited items without authorization.

Sheriff Ken Henderson commends the quick action and investigation into locating the cell phone and ultimately identifying the detention officer responsible. Sheriff Henderson wants it to be known that this type of behavior will not be tolerated, and that detention center security is very important.

#### SEARCH FOR RECKLESS DRIVER ENDS IN ARREST

Georgia State Patrol, and Union County Sheriff's Office were in pursuit of a reckless driver coming into Towns County on Hwy 76 East. The vehicle wrecked on Byers Creek Road at Red Farm Road.

The suspect ran from the scene on foot. The Towns County Sheriff's Office deputies, along with Union County's tracking K-9, and the Towns County drone were called to assist in the search for the suspect. Residents were immediately alerted through the Sheriff's Office Facebook page.

Towns County Sheriff Ken Henderson thanks the community for calling in locations of sightings for the suspect. A Towns County resident saw the subject running on his property and notified deputies on the scene as to the direction of travel.

Towns County Sheriff's Office Captain, Johnny McCoy, observed the suspect crossing a field where he took the suspect into custody without incident.

#### **MISSING PERSON**

Tracking K-9's, a Georgia State Patrol Helicopter and a Towns County Sheriff's Office Drone Unit has been involved with the search. A foot search of the area has also been conducted with negative results. The area around Mr. Murphys\* residence is steep and heavily wooded making it extremely difficult to search.

Mr. Murphy has some very serious health issues that require medication and needs to be located as soon as possible for him to be ok.
